### RULES AND REGULATIONS

1. Consignment fee of \$100 per head. Commission of 8%.
2. No Sale Fee – There is a \$150 NO SALE FEE, in addition to the consignment fee, that will be assessed if the owner does not accept the final bid. If a horse is sold on the grounds after it has been through the ring, that sale must go through the sale office.
3. CATALOG DEADLINE IS AUGUST 13, 2010 AT 12:00 PM.
4. Horses will be sold in catalog order.
5. Horse that are known to have any problems, such as lameness or breathing problems, must be announced during the sale.
6. Stalls and bedding will be provided. Bring your own feed.
7. Your horse is cataloged for the benefit of advertising the horse and giving everyone a fair opportunity to bid on the horse. Once a horse is cataloged, we DO expect the horse to be brought to the sale. Upon execution of the contract, consignor agrees not to dispose of the horse by private sale. Any horse withdrawn from the sale, for any reason other than infirmity, will be assessed a \$400 penalty in addition to the \$100 catalog fee.
8. The sale company reserves the right to refuse any entry.
9. A current health certificate and a Negative Coggins Test taken within the last 6 months must be submitted during check in of the horse for sale.
